SERVICES AVAILABLE TO YOU

Certified Home Health Aide:

One of our licensed professionals will assist with all activities of daily living (bathing, grooming, dressing, etc). Each employee is licensed, bonded and completes ongoing background checks. They are available for hourly, shifts, overnights, respite and live-in care.

Bible Study:

We provide in home Bible Study to the sick and shut in. Please call 1-866-777-2818 to make your request

Medical Transportation:

We will arrange private transportation to Doctor's offices and medical facilities (pending insurance approval). You will receive fast and reliable transportation which consist of Medical Vans, Wheelchair Vans and Emergency Stretchers.

Geriatric Care:

We will act as liaisons to family members of our patients, allowing them the opportunity to stay involved and informed. We will conduct an initial assessment at no cost to you. This will give us the opportunity to come together and determine you/your family members needs. We will assist with moves to or from an assisted living facility or nursing home. We will even take on the task of ordering any medical supplies needed (based on insurance approval).

Ask The Nurse:

Our very own Director of Nursing will act as a liaison to your physician. General questions requested will receive a response within 24 HRS. We will also act as a referral source for any and all medical needs such as Social Worker's, Physical Therapy, Occupational Therapy, medical equipment, etc). 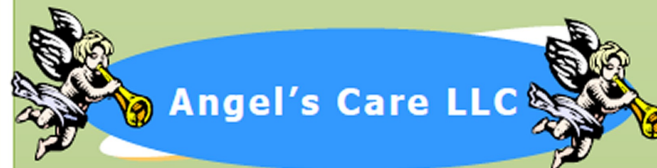
